- 2. Documents for Enrollment (New students), the candidates must submit: (All photocopies of documents must be signed by the applicants)
 - 2.1 Two copies of Bachelor's degree transcript (s);
 - 2.2 Two copies of Bachelor's degree certificate (diploma) or Letter of Certification of Bachelor's degree graduation approved by the University Council;
 - 2.3 Two copies of identification cards (for Thai citizens), or passport (for Foreigners);
 - 2.4 One copy of a household registration certificate;
 - 2.5 Medical certificate (Medical certification is not more than 1 month and show that the students does not suffer the critical illness and prohibited diseases. The student can require from government or private hospital d clinic);
 - 2.6 Three 1-inch photo taken no more than six months prior to application date;

- 2.7 Two copies of an official document indicating a name/family name change and a marriage certificate (if applicable);
- 2.8 For those who work, students must submit a full time student improvement letter;
- 2.9 All foreign students must have valid health insurance throughout the entire duration of their studies;

4. English Proficiency

- 4.1 Applicants must conform to the requirements of NIDA's current announcement on English proficiency requirements for the master's program students as follows:
- 4.1.1 Applicants who can be exempted from the requirement shall meet either the following:
- For those who enter into the Program with Bachelor's degree qualification, students must have completed a degree in a curriculum taught in English within the past 5 years from the starting date of the semester the students are registered with the Program.
- 4.1.2 Students can graduate from the Program only if their English proficiency meets the following standards
- Students must hold TOEFL 500 points or 60-70 (iBT) or higher score (paper-based or computer-based or internet-based), or 5.5 points in IELTS or higher. Yet, the scores must not be older than 2 years until the submission date, or NIDA TEAP (Test of English for Academic Purposes). The score must not be older than 1 years until the submission date.
- 4.1.3 Students who want to take the TOEFL/ITP exam must contact the School of Language and Communication, the National Institute of Development Administration only. For more information about TOEFL/ITP please contact the School of Language and Communication; Tel: +662-7273143, +662-7273155.

5. Registration Fee (Semester 1, Academic Year 2025)

6. Required Courses for Registration

Candidates are required to contact the Educational Service Division for enrollment on May 8 - 20, 2025, Candidates will then receive user name and password for registration via the internet at http://reg.nida.ac.th

- 7. NIDA reserves the right to NOT commence the programs of study in the semester scheduled, if the number of enrolees is less than 5 persons. In this case, the program will commence in the subsequent semester.
- 8. Applicants must conform to the requirements of NIDA's current announcement on English proficiency requirements for the International Program students as follows:
- 8.1. Students must submit the score of English Proficiency test, which can be the score of either NIDA TEAP, TOEFL or IELTS. The minimum score of the English proficiency test is stipulated in each school announcement.
- 8.2. Students who are waived from submitting the English proficiency test score of either NIDA TEAP, TOEFL or IELTS to be eligible for an interview session, must submit the score prior to the graduation. Period of English Proficiency score validation.
 - 8.3. NIDA TEAP score is valid for 1 year before the date of submission.
 - 8.4. TOEFL or IELTS score is valid for 2 years before the date or submission.

- 9. The decision whether students have to register for English for Graduate Studies courses will be made according to the English Program for Graduate School of Languages and Communication's rules and conditions.
- 10. For a study period, each program takes approximately 4-5 semesters and 1-2 summer semesters in order to complete, depending on individual program requirements.
